While each activity has a specific risk assessment and every effort is made by our staff to secure your safety during the period, by signing this disclaimer you hereby acknowledge that Poultec Training Limited shall not be liable for any inconvenience, injury, accident, delay, irregularity, liability or expense suffered by you, save where such is caused as a direct result of our proven negligence.

Furthermore, in signing this declaration, you are confirming your understanding and acceptance of the following rules: **General**

- 1. You will undertake all activities in accordance with the verbal safety instructions or written notices and any further advice/instruction given by Poultec Training Limited staff.
- 2. You will ensure that you fully utilise all protective equipment provided for your safety, under the supervision of Poultec staff during your visit.
- 3. You are voluntarily participating in the activities with the knowledge of the dangers involved and agree to accept any and all risks of loss or injury.
- 4. You will be supervised by Poultec Training Limited staff at all times however, you acknowledge that you are responsible for your own safety and the impact your actions may have on other users.
- 5. You must immediately cease any activity if you are concerned in any way about safety or if to continue would be unsafe for you or other users.
- 6. You certify that to the best of your knowledge you do not have a medical condition which might increase the likelihood of an accident which could result in injury to yourself or others. To the best of your knowledge you are not pregnant.
- 7. You confirm that you are not under the influence of alcohol or drugs during the activities.
- 8. For all activities, under 14s must be accompanied by a parent/guardian over the age of 18.
- 9. There is no age limit for using the Segway X2 Personal Transporter, however staff must be satisfied that users have the confidence to handle the Segway safely. To use the Segways, you must be at least 120cm (4ft). You must be between 45Kg and 117 Kg (7st and 18st)
- 10. If using the high ropes equipment, you must be 6 years or older. You must be at least 120cm (4ft) and be less than 117Kg (18st).
- 11. If using the mobile climbing wall, you must be at least 110cm (3ft 7ins) and be between 19kg (3st) and 108Kg (17st).
- 12. Bocarts must not be used before receiving a written and verbal safety briefing. Signing below confirms this.
- 13. The minimum age to participate on the Bocarts is 16yrs.
