Local Area SEND inspection

Ofsted and the Care Quality Commission (CQC) will carry out jointly an inspection of your local area. Under the Children and Families Act 2014, the government placed new duties on the local health, social and education services that provide for children and young people with SEND. The inspection will evaluate how effectively the local area:

- identifies the needs of children and young people with SEND
- meets the needs of these children and young people so that their outcomes and chances of participating fully in society improve.

The views of children and young people with SEND, and the views of their parents and carers will be gathered during visits to a number of early years settings, schools, colleges and specialist services. These views are critical to the inspection process. During the inspection, Ofsted and CQC inspectors will be keen to speak to as many children and young people and their parents and carers as possible. Inspectors will not be visiting your child's provision.

How can local children, young people, parents and carers contribute their views during this local area inspection?

There are several ways in which children, young people, parents and carers from your provision can engage with the inspection process and contribute their views:

1. The inspection will include an online recorded webinar to allow Norfolk's parents and carers of children with SEND to contribute. The webinar will take place from noon on Monday 24 February 2020 until 11:59pm on Tuesday 03 March 2020.

- 2. Parents and carers can contact their local Parent Carer Forum to request details of how they can attend the discussions held between parents and carers and the Ofsted/CQC inspection team. The local authority must also provide the details of this meeting.
- 3. Parents and carers can email their contributions to Lasend.support@ofsted.gov.uk.
- 4. Details about the local area SEND inspection will be available on your local authority's website and distributed through the local area's Clinical Commissioning Group/s (CCGs). Information about how children and young people with SEND can share their views about the local area's effectiveness should be included in the local offer.

During this inspection, the inspectors will collect information about children and young people in the area. They will be looking at local area records, speaking to area officers and leaders at educational

settings, and speaking to children, young people and parents or carers. No names will be recorded, but some of the information collected may be capable of identifying a particular child, young person or adult. Ofsted and CQC will use this information to prepare their report, and for the purposes set out in their privacy notices. No information will be published that identifies any individual in the inspection report.

Coronavirus concerns

We will continue to keep updated with the latest information as we receive it. In school we will continue to remind children about the importance of hygiene. We received the following information this week:

Re: COVID-19 Advice for schools and educational settings

You may be aware that advice for travellers from affected areas has recently changed and it has come to our attention that this may affect children and staff returning from school trips. Please be aware that this is a fast evolving situation and we will continue to share any new advice at the earliest opportunity.

As of today (25th February) advice for returning travellers is as follows;

- 1) If you have returned from the following areas **since February 19**, call NHS111 to inform them of your recent travel, stay indoors and avoid contact with other people **even if you do not have symptoms:**
 - Iran
 - Specific lockdown areas in Northern Italy* as designated by the Government of Italy
 - Daegu or Cheongdo, Republic of Korea)
 - Hubei province, China (returned in the past 14 days)
- * Bertonico Casalpusterlengo Castelgerundo Castiglione D'Adda Codogno Fombio Maleo San Fiorano Somaglia Terranova dei Passerini: Vo
- 2) If you have returned from the following areas since **February 19th** and develop symptoms, however mild, you should stay indoors at home and avoid contact with other people immediately and call NHS111. **You do not need to follow this advice if you have no symptoms.**
 - Northern Italy (see map)
 - Vietnam
 - Cambodia
 - Laos
 - Myanmar
- 3) If you have returned to the UK from any of the following areas in the last 14 days and develop symptoms of cough or fever or shortness of breath, you should immediately stay indoors and avoid contact with other people, call NHS 111 to inform them of your recent travel to the country.
 - Other parts of China outside Hubei province
 - Thailand
 - Japan
 - Republic of Korea
 - Hong Kong
 - Taiwan
 - Singapore
 - Malaysia
 - Macau
